### Art.3 - COMPETITORS AND DRIVERS

Entry to the Event is open to all holders of Driver License valid for this year according to the Regulations and to the Sporting Regulations of art. 1. Competitors and Drivers with foreign license can take part in the Event only if the Event is International or E.N.P.E.A. (see "Event status"). Classifications and points will be according to R.S.N.

#### Art.4 - ADMITTED CARS

The only admitted cars are the cars conformed to the respective Technical Regulations of the categories listed in Article 1. All cars must be under the security requirements in the All. "J" of the International Sporting Code and the ACI Sport Yearbook current rules. Cars numbers and advertising on car will be decided according to rules, to Regulation and to Sporting Regulations.

#### Art.5 - ENTRY FORMS

Entries must be sent within 18.00 hrs on **September 1**st **2023** according to the Sporting Regulations of the categories listedin Article 1.

The amounts of the Entry free to be paid are published in the respective Sporting Regulations of the categories listed in Article 1.

Submission of the entry form application to the Event shall be considered as an implicit declaration:

- to know, accept and undertake to respect and ensure compliance with the provisions of the Code, of the NSR and of the present Regulations;
- to acknowledge the sole jurisdiction of the local ASN and FIA with the exception of the right to appeal in accordance with the provisions of the Code and the applicable NSR;
- to renounce to any appeal to arbitrators or any other judicial body for facts relating to the organization and/or the running of the Event;
- to release the ACI Sport, the Organizers, its staff, the Marshals and in any case the persons assigned to the motor-racing track from each and every liability that should arise as a consequence of the trial that the undersigned intends to perform;
- to engage to let its Driver wearing, for all the event, fire-retardant protective clothing and homologated helmet according to FIA Rule, and to observe the ethic code of ACI Sport, exempting the Organizers, the Officials and ACI Sport from any responsibilities issued by ethic code. Any Drivers that don't observe the abovementioned rules can be excluded by the Event and referred to Sporting Justice.
- to respect in every moment the Sporting activity's basic principle, acting with loyalty.

All Drivers must comply with all of rules of conduct of ASN here considered literally and completely transcribed and also all of the instructions issued by the Race Director, the Clerk of the Course and the Stewards of the Meeting. All Competitors and Drivers must be at Stewards' disposal until the declaration of Official Classification.

### Art. 6 - INSURANCE

The Organizer, having a sporting license, accepts the present Regulation. The Organizer confirms to know that the RC insurance (ref. art. 56 RNS), responds to the art. 124 of insurances code, with the minimums of law. The insurance policy does not raise the Competitors and Drivers from their responsibility, in case.

#### Art. 7 - COMPETITION

The Event shall follow the attached Timetable, according to the features of the respective Sporting Regulations of the categories listed in Article 1.

# Art. 8 - QUALIFYING, ADMISSION TO THE RACE, STARTING GRID

Admission to the start and relative position on the grid will be according to the rules published in the current ACI Sport Yearbook and respective Sporting Regulations of the categories listed in Article 1, here considered integrally and completely reported.

The best time is on the right side of the starting grid (clockwise). Rolling start: Pole position on the right side of the

Standing start: Pole position on the left side of the track.

The number of admitted cars is in accordance with ACI Sport Year Book.

#### Art. 9 - PIT RULES

Pit rules should be absolutely respected by all Competitors/Drivers and their Teams.

Each Competitor will be responsible for the order of his pit area and for the behaviour of any person directly or indirectly linked with his participation in the Event.

In every moment of the Event Drivers must observe, and are responsibility for complying with the 60 km/h speed limit in the pit lane.

The speed limit is checked by Race Officials who act as judges of fact, whose judgements are final. Penalties for noncompliance with the 60 km/h speed limit shall be assessed in conformity with the Sporting Regulation of each Series.

#### Art. 10 - SIGNALS

Signals complying with the requirements of the RDS of ACI Sport – Extract of Appendix H of the Code will be used bothduring Qualifying and Races.

During Free Practice, Qualifying and Races, all Drivers must comply with all rules of Appendix H of the Code, as well as allthe instructions received from the Race Officials.

The exit of cars from pit lane, during Qualifying and Races is regulated by light.

## Art. 11 - SAFETY CAR

The use of the Safety Car will be accorded priority in all instances described in the RDS of ACI Sport. Thus, a Race will only besuspended if the Safety Car cannot or may not be brought out.

### Art. 12 - CLASSIFICATIONS

After each Race, will be drawn according to the respective Sporting Regulations of the categories listed in Article 1. The classifications will be published on the Virtual Notice Board.

### Art. 13 - PRIZES

The award procedure follows the relative Sporting Regulations of the categories listed in Article 1. The Ceremony is on the Podium after each Race.

### Art. 14 - PROTESTS AND APPEALS

Protests and/or appeals must be presented in accordance with the procedure described in the Code (we mean literally and completely transcribed).
