Conditions of eligibility

The Porsche Carrera Cup France Junior Programme is open to:

- Drivers who have never participated in a race in Porsche Carrera Cup or GT3 Cup Challenge.
- Drivers born between 01.01.2000 and 31.12.2008.
- Drivers with a proven track results in motorsport.
- Drivers holding a national or international license F.F.S.A. or a license issued by another N.S.A. (National Sports Association) affiliated to the Fédération Internationale Automobile (FIA).
- Drivers eligible for an international C Licence for the 2025 season.

If any of these criteria are not met, the application will be rejected.

Schedule of the Porsche Carrera Cup France Junior Programme

Junior Programme will take place from Saturday, November 09th, 2024 - 05:30 pm to Monday, November 11th, 2024

- 06:00 pm at the Circuit Paul Ricard and its surroundings.

During the Junior Programme, the participants will stay at the Grand Prix hotel in Le Castellet.

During the Junior Programme, the drivers will be supervised by the Porsche Carrera Cup France team and Patrick Pilet professional driver. Throughout their stay, the drivers will discover the Porsche brand and its values, while benefiting from personalized coaching.

Selection process for the Porsche Carrera Cup France Junior Programme

- 1- Complete the registration form in full and prepare a short presentation video (1 minute maximum) and send it before <u>October 04th, 2024</u> by email to the following address: <u>lgautier@oreca.fr</u>
- 2- The form will be studied by the organization of the Porsche Carrera Cup France Junior Programme, to validate or not the registration.
- 3- <u>After validation of the registration by e-mail</u>, you can make the payment as indicated below:
 - Total due : **2 500 € ex-vat** (3 000€ VAT incl.) payment by bank transfer to the order of Porsche France.

The payment of the registration fees will be done after the validation of the registration form by the organization. It must be made imperatively one week before the event.

Without the payment the driver will not be able to participate in the selection.

Appendix 1 – Regulations

1 - General

1.1 Organizing Committee

The Organizing Committee of the Porsche Carrera Cup France Junior Programme is composed of Porsche France, Oreca and Michelin

The Porsche Carrera Cup France is supported by the following partners :

1.2 Guarantees

Application of the general prescriptions of the F.F.S.A. C and D risks are compulsory.

Additional insurance is strongly recommended by the organizer.

In the event of an accident of any kind, while driving one of the vehicles used during the event Porsche Carrera Cup France Junior Programme, the driver agrees to take responsibility for all the financial consequences of the damage caused to the vehicle in which he or she is installed, within the limit of $10\ 000 \in$ (Ten thousand euros) and undertakes to pay this amount to the organizer without delay.

2-Sporting regulations

2.1 Drivers

The Porsche Carrera Cup France Junior Programme is open to all drivers who have never participated in a race in Porsche Carrera Cup or GT3 Cup Challenge, who were born between between 01.01.2000 and 31.12.2008, and justify a list of results in motorsport.

In addition, to participate, drivers must hold a national or international license F.F.S.A. or a license issued by another N.S.A. (National Sports Association) affiliated to the Fédération Internationale Automobile (FIA). Drivers must be eligible for an International C Licence for the 2025 season.

The entry fee must be paid to participate in the selection events.

2.2 Winner of the Porsche Carrera Cup France Junior Programme

The winner of the Porsche Carrera Cup France Junior Programme, who has been selected by the Organising Committee on the basis of sporting and non-sporting criteria (after evaluation), will receive a grant of €40,000 ex-VAT. This grant must be used to participate in the Porsche Carrera Cup France 2025 in the team of his choice.

He/she will also receive, from Michelin, an allocation of a set of 4 tyres to be used in the 2025 season. In addition, the winner will be declared « Junior Porsche Carrera Cup France 2025 ». His or her nomination will be announced during the two weeks following the selection.

The driver will also receive personal coaching during the 2025 season.

2.3 Payment of bonuses and prizes

The prize money will be paid to the team in which the Junior Porsche Carrera Cup France 2025 will sign for the 2025 season.

2.4 Special provisions

Participation in the Porsche Carrera Cup France Junior Programme means that all copyrights and image rights of the teams and drivers are transferred to Porsche France. This includes all images, videos and sounds from the Porsche Carrera Cup France Junior Programme that are taken for TV, press, DVD and internet broadcasting worldwide.

Data privacy: In accordance with the GPRD law of May 25, 2018, you have the right to access, rectify, oppose and delete data concerning you. You can exercise this right by writing to Porsche France, 25/29 Quai Aulagnier - 92600 Asnières-sur-Seine - FRANCE, or by e-mail to <u>rgpd@porsche.fr</u>.

The information collected by Porsche France in the context of this registration form is necessary to take into account the participation of each driver in the Junior Programme.

It will not be used for any other purpose than for the organization and running of the Junior Programme and the Porsche Carrera Cup France 2025. It will also not be transmitted to third parties other than service providers and partners of Porsche who need to know for the strict requirements of the organization and conduct of the Porsche Carrera Cup France 2025, without the express permission of drivers.

It is specified that personal data will be kept for the time necessary to manage the PCCF. Only those directly involved in the organization of the Porsche Carrera Cup France will have access to this data.
