

REGULATIONS OF THE FACILITIES

All regulations to be observed as regards the facilities and the general rules to be followed within the facilities of Circuit de Barcelona – Catalunya are described below.

AREA DISTRIBUTION

- 1 PIT GARAGE AND PIT-LANE AREA
- 2 PADDOCK AREA
- 3 SERVICE AREA
- 4 CAMPER AND MOTORHOME AREA
- 5 PARKING AREA

The distribution of the areas will be made by the organisation and all participants must follow the indications.

1 - PIT GARAGE AND PIT-LANE AREA

- Should there not be enough space available for all teams/participants, they will have to share the pit garage. Each pit garage will be divided into equal parts as regards: covered surface area, installations, pit lane working area and space at the signalling wall.
- It is forbidden to smoke, cook and/or spend the night inside the pit garage. Any placed stickers must be removed.
- Follow at all times the instructions of use for the pit boxes doors, placed next to them.
- We kindly ask you to be respectful with the use of the facilities and specially to respect the safety and environmental regulations, to be precise:
 - The use of the containers for dirty cloths.
 - The use of the manholes to collect faecal waters from the trucks.
- All participants must remove their waste after the end of the event.
- Should there be an accidental spillage, please proceed as follows:
 - Collect the product with absorbent materials: soil, absorbing blankets, sepiolite, etc.
 - Sweep the area, and collect everything in a bag.
- For security reasons, whenever there is activity on the track, the use of the pit-lane is restricted to essential personnel for the development of the activity.
- In case of doubt, please contact the "Info Teams" office located on the ground floor of the control tower.
- Please be informed that the infringement of these rules will be duly penalised and the Circuit reserves the right to charge for the damages caused.

2 - PADDOCK AREA

- It is not allowed to perforate or damage the paved surface of the paddock. The Circuit will charge for the damages caused.
- It is not allowed to block emergency exits, neither completely nor partially. The exits are duly signposted and marked in yellow.
- Any vehicle located within the paddock area must be correctly parked and duly accredited at all times.

3 - SERVICE AREA

- All companies having to provide services must be expressly authorised by the organiser and must have the respective credential or authorization, if necessary. They will have a dedicated area inside the paddock.
- Due to reasons of space, the organisation reserves the right to admit or limit the space in the service area for these companies.

4 - CAMPER AND MOTORHOME AREA

- Participants using a caravan or motorhome, shall notify the organisation in order to get a place allocated in the respective area. The installation of tents or pools will be only under authorization.
- In this area, it will be forbidden to turn on engines, as well as make any other kind of noise, as it will be the rest area for participants.
- This area is dedicated to the use by riders/drivers and team staff. The organisation reserves the right of admission to this area.

5 - PARKING AREA

- The organiser will provide for a parking area, as close as possible to the paddock, for the participants' vehicles.
- All vehicles must be duly accredited at all times.

REGULATIONS OF THE FACILITIES

PARTICIPANTS' BEHAVIOUR

- It is not allowed to sleep inside the pit garages.
- As regards the use of scooters, it is not allowed to:
 - Ride or be passenger if you are under 16 years old
 - Ride with more than one passenger
 - o Ride recklessly
 - Ride without wearing a helmet
- The speed limit within the facilities is 30 km/h.
- Children under 16 years old are not allowed to access the pit garages, the pit lane and the service track, regardless of whether they are duly accredited or not.
- The directions sense of service roads and other interior areas must be respected at all times.
- It is compulsory to be correctly dressed at all times (top, bottom and footwear).
- It is forbidden to smoke, light fires and store gas containers inside the pit garages. This prohibition is also applicable to the pit lane area.
- Cooking is only allowed in the hospitality area (second line of the paddock) and in the motorhome area.
- It is forbidden to ride/drive on the track with any type of motor vehicle during the times not scheduled for practices or races. Any participant infringing these regulations may be penalised at the organisation's criteria.
- It is forbidden to exchange personal and/or vehicle passes.
- Participants are responsible for the actions of any of the team members and their companions.

FACILITIES

- Animals are not allowed inside the facilities, except for service dogs.
- Participants are responsible for leaving the facilities in the same condition in which they found them. It is not allowed to paint, drill and/or misuse the facilities.
- Any damages caused to the facilities will be under the responsibility of the competitor.
- Used tyres and containers must be removed by the participants. It is forbidden to leave them in any area of Circuit de Barcelona – Catalunya. The participant is the only responsible for these materials. In case of infringement, a fixed amount of €30 + VAT for waste management and €7 + VAT for each tyre/container for recycling will be charged.
- Any used oil, batteries, etc. must be placed in the dedicated containers and/or in the Green Point of the circuit (warehouse area).
- In your own interest, please take care of your personal belongings at all times.

Dear All,

Fira Circuit S.L.U., contributing with its actions to achieve the Sustainable Development Goals of the 2030 Agenda, and continuing with Circuit's de Barcelona-Catalunya commitment based on a **3C management "Conscience, Commitment and Coherence"**, certified with the **ISO 14001** since 2008, the **Biosphere** commitment since 2020, **ISO 20121** for 5 races and recently certified with the **CSR Management System aligned with the Sustainable Development Goals**, would like to invite you to carry out the **European Le Mans Series** in a socially, economically and environmentally sustainable way.

To achieve this, it is necessary that all stakeholders involved in the development of the race behave responsibly in the following aspects:

• Responsible use and consumption of water.

Currently, Catalunya is going through an extreme drought from which derives an unprecedented and exceptional restriction that limits the use of this scarce resource to essential needs only. Therefore, **the usage of water to fill up swimming pools and/or for cleaning vehicles is strictly prohibited**. If necessary, use a sponge and a bucket to clean the front and back windows of your vehicle.

Find below **specialized places** where you can clean your trucks:

On the other hand, water is now drinkable at the Circuit. You will find 7 water fountains in the paddock in which you can refill your bottles.



• Make a good use of **energy**.

Since 2017, the electricity supplied to the Circuit is **100% of certified renewable origin**.

The Circuit is committed to energy self-sufficiency and currently has a total of **2,319 solar panels** that occupy a surface of **5,274 m2** and generate an **annual volume of energy of 1.34 GWh.** In total, the installation generates 50% of the energy consumed annually. Of the total of 2,319 panels, 1,092 are installed on the roof of the Main Grandstand, 1,080 on the roof of the pit building and the rest on the roofs of the washroom building in the Paddock, the Crystal office building and the Services building.

We also have installed a canopy which is used to produce the energy used to charge up to 6 vehicles underneath it

To promote the use of electric vehicles we have **14 electric vehicle recharging points** within our facilities, 5 of which, in the paddock, next to the fuel station. Please do not use the recharging points as parking. Once your vehicle is fully charged, leave the recharging point available to be utilized by other users.

• KM0 Restaurant of the Circuit offers healthy and Km0 food.

Km0 gastronomy avoids long journeys of food by means of transport and therefore reduces CO2 emissions.

- Zero Waste: The best waste is no waste
 - 1. Please use water fountains instead of single-use plastic bottles.
 - 2. Join the **STOP FOOD WASTE** campaign and don't waste food.
 - 3. Waste and Circular Economy. Please use the bins to dispose of your waste in the appropriate containers. At the **recycling points in each of the paddock towers** you will find the different types of containers to recycle correctly and to recover organic waste, glass, packaging and cardboard. **Find attached the recycling guidelines**.
 - 4. Please use the containers for the collection of **soiled rags** only and the drums for **waste oil** only. **No other liquids or materials should be placed in these drums.**

The totality of the domestic waste from the event is segregated in containers for: organic, packaging, cardboard, glass and oils. Thanks to everyone's collaboration, we have managed to recover, together with **ECOEMBES**, **739.875 kilos of waste since 2008**.



• Connect with nature. Sustainable Forest management.

Take a break and visit the Circuit's Educational Crater Forest. The Catalan track is a sports facility that is home to **more than 25 hectares of forest**. For this very reason, Circuit de Barcelona-Catalunya launched in 2019 a project to improve the biodiversity of its forest with the collaboration of a sustainable forest management company aimed at the training and job placement of young people in a situation of social exclusion.

The aim is to **improve our biodiversity**, **creating a native**, **autonomous**, **more attractive**, **and environment-friendly ecosystem**, adding an educational value, by means of boards describing the actions carried out in the forest, for the enjoyment of and to raise awareness among the attending public.

• Social Commitment.

Finally, we want to insist on the importance of **donating uncooked leftover food** instead of throwing it away, which we deliver to the social diner **El Xiprer, in Granollers**, and thus help several families in poverty. This solidarity requires the effort of everyone and the objective of our commitment to sustainability should be none other than to collect 100% of the leftover food from the competition. **Since 2017 we have donated more than 21,000 kilos**. Please find attached the information on the protocol of the food collection.

We invite you to join in all the actions and we count on your commitment and responsibility.

Dear All,

We would like to inform you that the Catalan Government has approved on 28th February 2023 a decree-law to protect water supplies, to provide legal framework to speed up procedures for the actions to be carried out, as well as to dissuade and penalise possible non-compliances. The main objective of this Decree-Law is focused on the implementation of measures to guarantee the supply of water to the population. As of now, and after the publication of the "*Resolució ACC/2311/2024, de 25 de juny*", the Circuit de Barcelona-Catalunya continues in alert status for hydrological drought.

From our **commitment to the environment**, Circuit de Barcelona-Catalunya is very alert to the exceptional situation due to drought, and that is why we are working on restrictions to minimise water consumption in our facilities. For this reason, **we ask you to prioritise water saving** as much as possible and to **use it as efficiently as possible** when carrying out your tasks at the Circuit.


In more specific cases, such as the **cleaning of vehicles**, we recommend that you go to commercial establishments dedicated to this activity and that have water recirculation systems. Inside the Circuit de Barcelona-Catalunya venue it is only allowed to clean windows, mirrors, rear-view mirrors, lights and number plates by using a sponge and a bin; as well as in cases where it is necessary to maintain the safety and health of people (transport of food, ambulances, medical vehicles and transport of medicines, transport of waste, etc.). In any of these cases, the cleaning shall be carried out using the **minimum amount of water possible**.

We would like to thank you in advance for your cooperation in dealing with this exceptional situation and remain at your disposal to clarify any doubts you may have.






PLASTIC WASTE
